Minutes of the Regular Council Meeting of the City of Maud

June 16th, 2025

The Maud City Council met in regular session on June 16th, 2025.

- 1. The meeting was called to order at 7:00 PM by Vice Mayor Kurtis Dustman.
- 2. The Pledge of Allegiance was led by Vice Mayor Dustman.
- 3. The Roll Call was made by City Clerk David Zeller. Present for the meeting were Council Members Lee Davis, Kurtis Dustman, Bobby Shatto and Chad Votaw. Mayor Jimmy Porterfield was absent due to a family emergency. City Attorney Mat Thomas was also present. The Vice Mayor Declared a Quorum.
- 4. The Vice Mayor welcomed the visitors.
- 5. Megan Cline addressed the council regarding issues with her neighbors on W Young street.
- 6. Chad Votaw moved to approve the consent agenda. Lee Davis seconded. The vote was Votaw-aye, Davis-aye, Dustman-aye, Shatto-aye. The Vice Mayor declared the motion carried.
- 7. No items removed.
- 8. Interim Police Chief Orrin Beckham reported that the PD has responded to 42 calls this month. They made multiple traffic stops. They responded to an attempted suicide, a pepper spray incident, a medical call, and several animal calls. They also responded to a hostage situation with assistance from Pottawatomie County Sheriff's Deputies and Shawnee PD SWAT team. They trespassed one individual from City properties. They impounded one vehicle. They issued several code violations. Chief Beckham is updating inventories for the PD Equipment. Chief Beckham has hired Marshall Jones as a full time officer and has brought on two more reserves.
- 9. Emergency Management Director Zeller reported that we are still experiencing unusual rainfall events that have caused some minor flooding problems in the city.
- 10. Robin Ueltzen and Braquel Stephens from Pottawatomie County 911 addressed the council regarding addressing in the City. They will be remapping the city addresses to conform to Nextgen 911 addressing standards. They will notify the homeowners and the City of addresses that are changed. The changes are to insure that first responders are able to respond to emergencies in a timely manner.

- 11. Lee Davis moved to approve budget amendments 2025-01 thru 2025-06 for the FY 2024-2025 Fiscal year as presented. Kurtis Dustman seconded. The vote was Davis-aye, Dustman-aye, Shatto-aye, Votaw-aye. The Vice Mayor declared the motion carried.
- 12. Lee Davis moved to approve Resolution 2025-4, approving the City of Maud, Oklahoma Budget for FY 2025-2026 and Establishing Budget Amendment Authority. Chad Votaw seconded. The vote was Davis-aye, Votaw-aye, Dustman-aye, Shatto-aye. The Vice Mayor declared the motion carried.
