The Maud City Council met in regular session on September 15th, 2025.

- 1. The meeting was called to order at 7:00 PM by Mayor Jimmy Porterfield.
- 2. The Pledge of Allegiance was led by Mayor Porterfield.
- 3. The Roll Call was made by City Clerk David Zeller. Present for the meeting were Council Members Lee Davis, Bobby Shatto and Chad Votaw. Kurtis Dustman was absent. City Attorney Mat Thomas was also present. The Mayor Declared a Quorum.
- 4. The Mayor welcomed the visitors.
- 5. Lou Mize addressed the council regarding her being charged for a damaged water meter.
- 6. Lee Davis moved to approve the consent agenda. Chad Votaw seconded. The vote was Davis-aye, Votaw-aye, Shatto-aye. The Mayor declared the motion carried.
- 7. No items removed.
- 8. Police Chief Orrin Beckham reported that he had been in contact with other agencies to try to acquire more vests. The Kickapoo tribe has donated a 2010 Tahoe to the department. We have 2 reserves that started their Reserve Academy. The PD is assisting Teresa with Code Enforcement. This month the department made 4 arrests and investigated a burglary. The charge packed tor the burglary has been sent to the District Attorney.
- 9. Emergency Management Director Zeller had nothing to report.
- 10. Bobby Shatto moved to approve Street and Alley Purchase Order 20059. Lee Davis seconded. The vote was Shatto-aye, Davis-aye, Votaw-aye. The Mayor declared the motion carried.
- 11. The Council discussed a possible donation of the property at 100 E Main to the City. Chad Votaw moved to accept the donation. Lee Davis seconded. The vote was Votaw-aye, Davis-aye, Shatto-aye. The Mayor declared the motion carried.
- 12. The Council discussed a city-wide garage sale. Lee Davis moved to hold a city-wide garage sale on October 18-19, 2025. Chad Votaw seconded. The vote was Davis-aye, Votaw-aye, Shatto-aye. The Mayor declared the motion carried.

- 13. Chad Votaw moved to set the date for Halloween Trick-or-Treat for October 30, 2025 from 6 to 9 PM. Lee Davis seconded. The vote was Votaw-aye, Davis-aye, Shatto-aye. The Mayor declared the motion carried.
- 14. Mayor Porterfield discussed a Cruise night on October 10th to coincide with football homecoming. The cruise night would include food trucks and a band or a DJ. Chad Votaw moved to approve the cruise night for October 10, 2025 from 5-12 PM. Lee Davis seconded. The vote was Votaw-aye, Davis-aye, Shatto-aye. The Mayor declared the motion carried.

- 16. Police Chief Beckham informed the Council that the in-car ticket printers are in but we are waiting on the paper for them. He is working on getting our Ordinances uploaded to Geosafe. The Geosafe e-ticket system is free for 3 months, then \$25/mo per enrolled officer after the 3 month trial period.
- 17. Lee Davis moved to adjourn. Chad Votaw seconded. The vote was Davis-aye, Votaw-aye, Shatto-aye. The Mayor declared the motion carried and adjourned the meeting at 7:25 PM.
