

Minutes of the Regular Board Meeting of the Maud Municipal Authority

June 15th, 2026

The Board of the Maud Municipal Authority met in regular session on June 15th, 2026.

1. The meeting was called to order at 7:23 PM by Chairman Jimmy Porterfield.
2. The Roll Call was made by Secretary to the Board David Zeller. Present for the meeting were Board Members Lee Davis, Tara Kestler, Bobby Shatto, and Chad Votaw. City Attorney Mat Thomas was also present. The Chairman declared a quorum.
3. The Chairman welcomed the visitors.
4. No Public Comments.
5. Lee Davis moved to approve the consent agenda. Bobby Shatto seconded. The vote was Davis-aye, Shatto-aye, Kestler-aye, Votaw-aye. The Chairman declared the motion carried.

7. Public Works Superintendent Teresa Wilkerson was absent. Chairman Porterfield reported in her place that they had mowed the cemetery. We provided 3000 gal of water for the Roundup club to water the rodeo grounds for the recent senior rodeo. The crew potholed the fence post locations on the north and east side of the water plant where our water lines are. The crew repaired a sewer tap behind the fire station. They will be repairing the leak in the s-curve on Wanda Jackson tomorrow. They had 3 grave openings this month. James has been working on Heath's truck and grading roads. They turned off 3 accounts for non-pay.
8. Chad Votaw moved to approve Purchase Orders 70838 and 70840. Tara Kestler seconded. The vote was Votaw-aye, Kestler-aye, Davis-aye, Shatto-aye. The Chairman declared the motion carried.
9. Secretary Zeller presented the proposed budget for the Municipal Authority for FY 2026-2027. Lee Davis moved to approve the budget as presented. Chad Votaw seconded. The vote was Davis-aye, Votaw-aye, Kestler-aye, Shatto-aye. The Chairman declared the motion carried.
10. Chad Votaw moved to approve Resolution 2026-2, Setting Utility System Rates and Charges for the Maud Municipal Authority. Bobby Shatto seconded. The vote was Votaw-aye, Shatto-aye, Davis-aye, Kestler-aye. The Chairman declared the motion carried.
11. Bobby Shatto moved to approve Blanket Purchase orders 70832 thru 70837 for FY 2026-2027. Chad Votaw seconded. The vote was Shatto-aye, Votaw-aye, Davis-aye, Kestler-aye. The Chairman declared the motion carried.

12. Chairman Porterfield addressed the council regarding hiring a seasonal employee to assist with mowing and to help the Public Works crew while Teresa is undergoing Chemotherapy. Tara Kestler moved to authorize the hiring of a seasonal employee. Chad Votaw seconded. The vote was Kestler-aye, Votaw-aye, Davis-aye, Shatto-aye. The Chairman declared the motion carried.

13. Bobby Shatto moved to adjourn. Tara Kestler seconded. The vote was Shatto-aye, Kestler-aye, Davis-aye, Votaw-aye. The Chairman declared the motion carried and adjourned the meeting at 7:44 PM.
