The Board of the Maud Municipal Authority met in regular session on March 17th, 2025.

1. The meeting was called to order at 7:21 PM by Chairman Jimmy Porterfield.

They have done several grave openings. Teresa wrote 13 Code Enforcement tickets and 20 Code Enforcement letters. We have a new company to buy chemicals from. 9. Kurtis Dustman moved to approve Blanket Purchase order 70475 to Mid-America Chemical for \$5000.00. Lee Davis seconded. The vote was Dustman-aye, Davis-aye, Shatto-aye, Votawaye. The Chairman declared the motion carried.

10. Joan Ellefson of Maguire Water was in attendance and discussed the proposed maintenance contract for inspection and maintenance of the Water Tower. After the discussion, Lee Davis moved to approve the contract with Maguire Water for inspection and maintenance of the Water Tower. Chad Votaw seconded. The vote was Davis-aye, Votaw-aye, Dustman-aye, Shatto-aye. The Chairman declared the motion carried.

11. The Board discussed hiring a seasonal employee to assist with mowing. Chad Votaw moved to authorize Superintendent Wilkerson to hire a seasonal employee for a period of up to 4

months. Bobby Shatto seconded. The vote was Votaw-aye, Shatto-aye, Davis-aye, Dustman-aye. The Chairman declared the motion carried.

12. The Chairman provided an update on the consent order from DEQ. We have received the new consent order for a six month monitoring period. Provided we don't violate our permit during those six months, the Consent Order will be closed out. No further action.
